What Information We Collect, Use, and Why

We collect or use the following information to **provide services and goods, including delivery:**

- Names and contact details
- Addresses
- Date of birth
- Purchase or account history
- Payment details (including card or bank information for transfers and direct debits)
- Health information (including dietary requirements, allergies and health conditions)
- Account information
- Identification documents

We collect or use the following information for **the operation of customer accounts and guarantees:**

- Names and contact details
- Addresses
- Payment details (including card or bank information for transfers and direct debits)
- Purchase history
- Account information, including registration details

We collect or use the following information to **prevent, detect, investigate or prosecute crimes:**

- Names and contact information
- Customer or client accounts and records

We collect or use the following information for **service updates or marketing purposes:**

- Names and contact details
 - Addresses
 - Purchase or viewing history

We collect or use the following personal information for **dealing with queries, complaints or claims**:

- Names and contact details
- Account information
- Relevant information from previous investigations
- Customer or client accounts and records
- Information relating to health and safety
- Correspondence

Lawful Bases and Data Protection Rights

You can request other information such as details about where we get personal information from and who we share personal information with. Details are passed to Ravenair to facilitate AOC flights where required, as well as completion of aircraft documentation (e.g. technical logs) required by law.
